Drivers may use the Broome County Library bathrooms from 9:00am to 8:00pm Monday through Thursday, and 9am to 5pm Friday and Saturday. In addition the drivers County ID will remain active to access the County Office Building restroom. Please review the **revised** accompanying map for bus docking locations and routing directions.

These changes will take effect on Tuesday, September 2, 2008.

A-DOCK – OUTBOUND

Outbound routing for the # 5 Vestal Ave: East on Court St to right on Fayette to right onto Hawley St left onto State St bridge bear right onto Conklin Ave on-ramp continue on regular routing. (Make stop on Hawley St on former B – 3)

Outbound routing for # 12 Conklin: East on Court St right onto Tompkins St. continue regular route.

NEW - Outbound routing for the # 40 Chenango St: & # 28 Robinson: East on Court St to left onto Fayette St to left onto Henry St to right onto Chenango St, continue on regular routing.

Outbound routing for the Corporate Park: East on Court St to right on Fayette to right onto Hawley St left onto State St bridge bear right onto Conklin Ave on-ramp continue on regular routing. (Make stop on Hawley St on former B-3)

NEW - Outbound routing for the #48: East on Court St to right onto Fayette, to right onto Hawley St to left onto Court St, (stop at old Junction B-3 as needed) stop at Boscov's, continue on route.

Outbound routing for the M & K Commuters: East on Court St onto regular routing.

B-DOCK – OUTBOUND

Outbound routing for the # 35 Endicott: West on Court St continue on regular routing.

Outbound routing for the # 7 Clinton and # 8 Front St: West on Court St to right onto Front St continue on regular routing.

Outbound routing for the # 15 Leroy St: West on Court St to left onto Oak St continue on regular routing.

Outbound routing for the # 23 Johnson City: West on Court St to left onto Front St continue regular routing.

NEW - Outbound routing for the # 3Park Ave: West on Court St to left onto State St onto regular routing.

NEW - Outbound routing for the Shopper's Special: West on Court St to left onto State St onto regular routing.

A-DOCK – INBOUND

Inbound routing for the # 5 Vestal Ave: # 434 to right onto Hawley St to left onto Carroll to right onto Court St into A-Dock. (**Stop at old Junction "A" dock as needed**) (When coming in to change to # 15 make left onto Fayette St and left on Court St into "B" Dock)

Inbound routing for the # 7 Clinton (Changes to the # 40) St & the # 8 Front St: (Changes to the # 12) Court St into "A" Dock. (Stop as needed in front of the Family Dollar store at Court and State)

Inbound routing for the # 35 Endicott: (Changes to the #28) East on Court St into "A" Dock. If continuing on as an outbound # 35 Endicott, drop off on "A" dock, then continue on Court St to left onto Chapman St to left onto Henry St to left onto Fayette St, to right onto Court St into "B" dock.

Inbound routing for the Corporate Park: Conklin Ave to left onto Tremont St to on-ramp to State St Bridge, to State St to right onto Court St into "A" Dock.

NEW – Inbound routing for the # 48: Court St into "A" Dock, unload and go.

B-DOCK – INBOUND

NEW - Inbound routing for the # 3 Park Ave: # 434 to Susquehanna St to left onto Fayette St to left onto Court St into "B"-Dock.

NEW - Inbound routing for the # 28 Robinson St (changes into the # 35) & # 40 Chenango St (changes into the # 7): Chenango St to left onto Henry St to right onto Fayette to right onto Court St into "B" Dock.

Inbound routing for the # 12 Conklin Ave: (Changes to the # 8) West on Court St into "B"-Dock.

Inbound routing for the # 15 Leroy St: (Changes into # 5; Court into "A" Dock) Court St left onto Carroll St to right onto Henry St to right onto Fayette to right onto Court St into B-Dock.

NEW - Inbound routing for the # 23 Johnson City: (Changes into the # 3Park Ave) Court St to left onto Carroll St to right onto Henry St to right onto Fayette, to right onto Court St into "B" Dock B-Dock.

NEW - Inbound Routing for the Shopper's Special: Susquehanna St to right onto Fayette to left onto Court St into "B" Dock.
